	<ul> <li>Contact the school/child care to let them know about this result.</li> </ul>
	They should isolate (stay home) and not leave except to get tested or for a medical emergency.
	<ul> <li>Talk with a doctor/health care provider to get advice or an assessment, including if they need a COVID-19 test.</li> </ul>
	<ul> <li>Household members without symptoms may go to school/child care/work. Check your local public health unit's website or call to see if they have different rules based on local risk.</li> </ul>
	If you answered "YES" to only one of the symptoms included under question 2:
	Contact the school/child care to let them know about this result.
	<ul> <li>They should isolate (stay home) for 24 hours and not leave except for a medical emergency.</li> </ul>
	<ul> <li>After 24 hours if their symptom is improving, they can return to school/child care when they feel wel enough to go. They do not need to get tested.</li> </ul>
	<ul> <li>Household members without symptoms may go to school/child care/work. Check your local public health unit's website or call to see if they have different rules based on local risk.</li> </ul>

	<ul> <li>Contact the school/child care to let them know about this result.</li> </ul>
	<ul> <li>They should isolate (stay home) and not leave except to get tested or for a medical emergency.</li> </ul>
	<ul> <li>Talk with a doctor/health care provider to get advice or an assessment, including if they need a COVID-19 test.</li> </ul>
	<ul> <li>Household members without symptoms may go to school/child care/work. Check your local public health unit's website or call to see if they have different rules based on local risk.</li> </ul>
